## **District Wide Budget**

Chair McDonough motioned to budget \$2.50 per gallon for oil. The motion was seconded by Malcolm Macleod. The motion passed with a 7-0 vote.

Gretchen Gandini motioned to approve the District Wide Budget of \$10,215,377. Jeanin Onos seconded the motion which passed with a 7-0 vote.

Anthony Sperazzo presented the high school budget.

Jeanin Onos motioned to approve the Gilford High School Budget of \$4,253,178. Chris McDonough second the motion which passed with a 6-0-1 vote. Kyle Sanborn abstained from the vote.

## **Technology Budget**

Brenda McGee presented the Technology Budget. Discussion ensued.

Jeanin Onos motioned to purchase 35 computers for Gilford High School. Kyle Sanborn seconded the motion which passed with a 7-0 vote.

Jeanin Onos motioned to approve the Technology Budget of \$560,802. Gretchen Gandini seconded the motion which passed with a 5-0-2 vote. Michelle Heyman and Malcolm MacLeod abstained.

# **Buildings & Grounds Budget**

Ken Mulleavey and Amie Leigh presented the Buildings and Grounds Budget.

Discussion ensued on the following topics:

Chair McDonough motioned to reduce \$7,000 from the plumbing heating line at the elementary school. Gretchen Gandini seconded the motion which passed with a 5-0-2 vote. Michelle Heyman and Malcolm MacLeod abstained.

Chair McDonough motioned to reduce the elementary school propone line by \$1500 bringing it to \$2499. Gretchen Gandini seconded the motion which passed with a 5-0-2 vote. Michelle Heyman and Malcolm MacLeod abstained.

Chair McDonough motioned to reduce the custodial substitute line at Gilford Middle School by \$3,000. Gretchen Gandini seconded the motion which passed with a 5-0-2 vote. Michelle Heyman and Malcolm MacLeod abstained.

Gretchen Gandini motioned to increase the high school c/s special project line by \$1,000. Malcolm MacLeod seconded the motion which passed with a 7-0 vote.

On a motion by Malcolm MacLeod and a second by Gretchen Gandini, the Board voted unanimously to adjourn the meeting.
